No objections have been raised. The Petition submits that the Estate is insolvent following a foreclosure on the sole property asset. Petitioner asserts there are no assets to pay any compensation or claims. The Court notes that the amount of statutory compensation is not calculated correctly, as Petitioner failed to account for losses on sales, which would be the amount of equity lost in the foreclosure sale. The property appraised at \$210,000. Insufficient information is provided on the amount paid for the property in the foreclosure sale, or the

amount of the encumbrance at the time of the foreclosure sale, although documents indicate that the original loan amount was approximately \$182,000, which would indicate that there was approximately \$28,000 in equity that was lost. The paperwork should be amended or supplemented to reflect this loss and correctly state the amount owing for the attorney's compensation. The personal representative has indicated she is waiving any request for compensation.

In addition, no explanation is provided for the personal representative's failure to make the property productive during administration of the estate. Decedent died on June 11, 2016, and the house was not lost to foreclosure until February of 2018, a period of 20 months. The personal representative could have rented the property or attempted to sell it. Instead, it appears that the personal representative resided in the property for at least those 20 months, failed to pay the mortgage payment or any rent, and that presumably resulted in damage to the estate and detriment to the other heirs. An explanation is required as to why the personal representative should not be surcharged for damage to the estate. The matter is continued to **Monday**, **June 25**, **2018**, **at 2:30 p.m. in Department 7** for further proceedings. **No appearance is necessary on today's calendar.**

If the request for abatement is treated as an objection or defense, then it appears to be more properly addressed at the noticed hearing on June 4, 2018. If it is to be treated as a separate affirmative request requiring its own

Notice of Hearing, then the parties should be prepared to discuss if any further notice is required. An appearance is required to address if there is any objection to the Court ruling on the request at this time, or reserving the issue for the June 4, 2018 hearing on the Petition.
